## RE: Seatbelt assemblies for motor vehicles – AS 2596

# **About the College**

# Our response to the consultation

The ACRS welcomes the opportunity to comment on the proposed draft standard in relation to seat belt assemblies in motor vehicles. Seat belts undoubtedly save lives, but are also associated with spinal, abdominal and pelvic injuries, which may be reduced when seatbelts are applied correctly.<sup>1</sup>

- 1. The definition is clear, a Safety Belt (Seat-belt, belt) is an arrangement of **straps** with a securing buckle, adjusting devices and attachments......
- 2. We have a generalised understanding that a seat belt is just the webbing part and disregard the 'securing buckle'

## **MODIFICATION TO DRAFT STANDARD:**

Appendix ZA

ZA.1 Instructions for installation

ADD: With reference to the Definition of a Safety Belt, Installation must include both
the seat belt and securing buckle as supplied in a Certified Kit. Mixing parts from
different manufacturers could be dangerous.

## ZA.2.2 Warning

ADD: The safety belt (seat belt) and securing buckle MUST be fitted as a pair.

## **SUPPORTING INFORMATION:**

The Standard specifies a Testing and Certification process to prove the effectiveness of the restraint system in an impact crash situation. This testing process requires a safety belt and securing buckle fitted together on the test rig. These parts generate the Certification once all the items pass the testing. In order for this proven product to be effective it **MUST** be fitted as a complete kit. Packaging requires both parts to be supplied, its only logical that they be fitted together.

The use of an existing component, because it does not 'look' damaged is dangerous.

As manufacturers have differing manufacturing processes and components, products from different manufacturers MUST NOT be mixed. Mixing parts will void the Certification for the 'kit'.
